REPORTS

Township Board Representative - Hodulik

- 1. A 5 year recycling contract has been made with no change in cost, with the cost reflected on the tax bill.
- 2. Road maintenance will be a priority in 2023. Both dump roads will be crack sealed, then tarred & chipped, followed by application of a sealer. Indian Point Road's ranking two years ago was a "9" but has fallen to a "2", and there will be another meeting with Matt Hall, County Road Commission Manager before action on the road is taken.
- 3. There is a new township website, www.burttownshipcheboygan.gov
- 4. There is also a new township accounting system. Kosanke is finishing up the audit.
- 5. Trail washouts have been repaired by Mike Spierling.
- 6. Wednesday, there was a meeting with MDOT on how to get paved shoulders on Topinabee Mail Route and to use signs for bikers and pedestrians on crossing the bridge over I-75.

ZBA -Jontz

A variance for Jonathan Scheel, 9662 Brutus Road, Brutus, MI 4971 for a second accessory building was denied because the lot is too small for a second building, property lines are unmarked, and setbacks are not within zoning restrictions.

High Speed Internet

Allen Kozlowski was able to speak with the regional manager of Spectrum and was told that it will be installed next spring/summer on West Burt Lake Road and the surrounding area.

PLANNING CONSULTANT –Ken Lane of Beckett & Raeder

Discussion regarding the definition and ordinance for fire pits and surround area led to motion by Kozlowski and supported by Hodulik to approve as written.
