## Review of Accessory Buildings and Structures Proposed Draft Amendment

The planning commission members discussed the contents of the attached email received from Jay Jontz.

#### Motion

Moved by Gene Hodulik and seconded by David Hutto to hold a Public Hearing on July 21, 2014, concerning the following additional proposed revisions to the Burt Township Zoning Ordinance concerning Accessory Buildings and Structures:

In Section **6.04.01** - **Accessory Buildings on Property with Principal Use** add a new column titled Max Building Footprint in the Zoning District WR 1,200 square feet and All Others 1,800 square feet; and change the Max Size (including the square footage for All floors) to Zoning District WR 1,800 square feet and All Others to 2,400 square feet; and in **Section 6.04.2** - **Accessory Building as a Principal Use, except in Waterfront Residential District** in paragraph 1.C. change 1,800 square feet to 2,400 square feet.

Motion unanimously approved.

## Review of Gas and Oil Processing Facilities Draft Amendment

Moved by David Hutto and seconded by Bob Babcock to recommend the draft amendment to the Burt Township Zoning Ordinance concerning Gas and Oil Processing Facilities to the Burt Township Board for approval and in the interim to send it to the Cheboygan County Planning Commission for its review and comments.

Motion unanimously approved.

#### **Review of Sign Ordinance Draft Amendment**

Gene Hodulik said the size of the sign is not included in Section 6.14.1 paragraph number 8 and that the words "not exceeding nine (9) square feet" should be added to paragraph number 8. Gene suggested that existing signs in the township be documented. It was discussed how signs are measured and that this should be defined in a future amendment to the sign ordinance.

Moved by Gene Hodulik and seconded by Bob Babcock to recommend the draft amendment to Section 6.14 of the Burt Township Zoning Ordinance concerning signs to the Burt Township Board for approval and in the interim to send it to the Cheboygan County Planning Commission

for its review and comments with the following change: the addition of the words "not exceeding nine (9) square feet" to paragraph number 8 of Section 6.14.1.

Motion unanimously approved.

Mary Campbell recommended that a discussion be held at the July 21, 2014, planning commission meeting on how signs are measured and measuring signs.

Mary Campbell reviewed proposed updates to Chapter 6 of the Burt Township Master Plan titled Community Goals and Objectives. Mary asked planning commission members to read and be prepared to discuss Chapters 7 and 8 at the next planning commission meeting.
