ZBA & Planning Appointments - Koviak

Dave Hutto e-mailed a request to be appointed to the ZBA. Jay Jontz would like to join the Planning Commission. Koviak's and Reimann's terms are expiring on the ZBA.

Topinabee Fire Report – Mike English

Mike English said they had 122 runs for 2016, 32 of which were in Burt Township. They now have 6-7 volunteers who have first responder or paramedic status and 3 more are pending. They will be getting a new set of Jaws of Life.

Republic Services - Hannah Palmer

The trash removal contract expires on January 31, 2017. Ms. Palmer offered a three year contract with the same terms as the previous contract. 2017 will have the same price as 2016 and the second and third years will be capped at 4 percent increases. They are also offering electronics and universal recycling. The board requested a price for a pallet for big dump day. **MOTION:** Moved by Hodulik, supported by Parker to contract with Republic Services for trash removal for three years.

<u>Deputy Clerk and Secretary Positions</u> – McDougall

McDougall will post ads in the Resorter and on the website for the positions. The deputy clerk must reside in Burt Township but the Secretary is not required to live here.

Zoning Administrator – Hodulik

The Board requested Larson to submit brief, monthly reports to the board and seek any training opportunities that would be beneficial to the position.

Committee Reports

Burt Lake Trail – Hodulik

The DNR Trust Fund approved a grant for \$295,000. The MDOT TAP grant committee met December 12, 2016, but the Trail Committee will not be informed of their decision until the end of January. Next Trail meeting is January 23.

<u>Planning Commission</u> – Hodulik

The Planning Commission met on December 12, 2016. Discussion on the vegetation strip was tabled. Other topics discussed were fireworks, signs and marijuana dispensaries, and rentals as commercial businesses. The Recreation Plan must be redone this year.

ZBA - Koviak

The ZBA met on December 7, 2016. An 8.6 foot construction setback variance was approved for Ken Parrish, and a change in the layout of the private shared access site dock system was approved for Beauwood Association beginning with the 2017 boating season. The request for a private shared access was tabled for PA Miller subdivision.

Zoning Administrator Report - Larson

24 zoning permits were issued in 2016. So far this year there has been one request for a pole barn and a request from an individual who wants a second set of stairs to the lake.

<u>Supervisor Report</u> – Koviak

The MTA Conference will be held April 10-13 in Lansing. Registration is underway. Tony Matelski is the new chair of the board of commissioners and Chris Brown is the vice chair. They will be looking at the county zoning and planning program.
