<u>Burt Township Zoning Ordinance – Signs Amendment</u> – Mary Campbell

Amendment of Article VI, Section 6.14 Signs

Planning Commission held a Public Hearing on January 19, 2015. Amendment to clarify how signs are measured. Information was submitted to the County Planning Commission who had no comment. Mary suggested that the Board wait until after the March 16th Public Hearing and approve all at the same time.

Amendment to change the allowable size of a fire pit to fourteen square feet

Section 6.12 – Waterfront Setback

Amendment to limit pervious pavers in the 75' setback to the 4' walkway

Section 6.13 – Fences, Walls and Hedges

Amendment to allow snow fencing and deer fencing up to eight feet in height in any zoning district between November 1st and May 1st.

Public Comments:

Chris Brown noted that the County ZBA is using lot coverage percentage as basis for zoning. Koviak said Burt Township zoning also uses that method.

2015-2016 Budget – Koviak

The Board reviewed expenditures and revenue for the 2014-2015 budget and discussed the proposed 2015-2016 budget. No road millage will be spent for 2015-2016. The budget will be finalized at the April meeting.

Public Hearing on the 2015-2016 Budget will be on April 2, 2015 at 1:30 pm.

2014-2015 Budget – McDougall

Decrease: Public Improvement – from \$10,000.00 to \$4,000.00 Increase: Planning & Zoning - from \$40,000.00 to \$46,000.00

Decrease: Township Hall – from \$20,000.00 to \$18,000.00 Increase: Miscellaneous – from \$1,000.00 to \$3,000.00

Transfer \$400.00 from the General Fund to the Liquor Fund

Burt Lake Trail Grant Application – Hodulik

Hodulik said he talked with Kyle Robinson from NEMCOG who said he had met with Brent Shank from the Cheboygan County Road Commission who said he thought paved shoulders on Riggsville Rd. won't happen as the State wants the whole road repaved due the poor condition. Kyle also called to Alex Nicolev in Lansing who is in charge of TAP grants and was told the same thing by him. An engineering study has not been completed and Kyle said it would be needed for the grant request.

Koviak said a grant needs to be ready for the repaving of Mullett-Burt Rd. in 2017. Russ Elmhirst said it would be better to get both Riggsville/E. Burt Lake Rd. and Mullett-Burt done at the same time so it would be cheaper.

Steve Vorenkamp said a preliminary engineering study has been done by C2AE.

Chris Kindsvatter suggested contacting Peter Petallia who is on the transportation committee for trail support.

It was agreed that the following is needed:

- 1) Get a meeting with the road commission
- 2) Get a copy of the C2AE engineering study

Vorenkamp suggested contacting Emily Meyerson for help.

MOTION: Moved by Hodulik, supported by Pillen to support a resolution to pursue funding from MDOT/TAP and the Michigan Trust Fund/DNR to further construct a consistent, hard

surface on the nearly 18-mile Trail extending from Topinabee to Maple Bay Campground on Burt Lake.

• May 5, 2015 Special Election - Proposal 15-1

A proposal to amend the State Constitution to increase the sales/use tax from 6% to 7% to replace and supplement reduced revenue to the School Aid Fund and local units of government caused by the elimination of the sales/use tax on gasoline and diesel fuel for vehicles operating on public roads, and to give effect to laws that provide additional money for roads and other transportation purposes by increasing the gas tax and vehicle registration fees.

Koviak said MTA is supporting this proposal.

- Annual Report from the Cheboygan Safety Dept. 129 permits were given in 2014, 8.24% of which were given in Burt Township.
- Cheboygan County Community Development Dept. sent a letter requesting that Burt Township submit any proposed CIP projects planned for 2016-2021. Clerk McDougall will reply that Burt Township will continue to work on the Burt Lake Trail project but has no other planned projects.
- Pellston Fire Dept. submitted a letter requesting a 3% increase for fire protection for 2015.
