New Business 2015-2016 Budget

BUDGET RESOLUTION Resolution #3-2015

Whereas anticipated revenues of Burt Township of the fiscal year 2015-2016 including millage, State, miscellaneous and other revenue will be \$984,608.77 in the General Fund and \$\$1,245.88 in the Liquor Fund and expenditures will be \$414,800.00 in the General fund and \$784.00 in the Liquor Fund.

Whereas a budget has been prepared for the expenditures, distribution, and allocation of such revenues during the next year,

Whereas the Township Board is now satisfied that the budget prepared is reasonable and in the best interest of the Township, now, therefore to govern the expenditures of the Township,

Be it therefore resolved that it is the expressed interest of the Township Board that is budget be adopted and managed by individual accounts.

# <u>Presque Ile Electric & Gas</u> – Hodulik

PIE&G has been working to expand in unserved areas in northern Michigan. DTE stopped them from getting approval in 11 areas, including Burt Township, even though DTE had no intention of servicing those areas.

PIE&G suggests that officials and residents send letters to Reps. Pettalia and Chatfield to get them on board to continue the effort to get natural gas in Burt Township. Koviak suggested putting it in the summer tax newsletter. Hodulik will ask PIE&G to write a sample letter for residents to sign. McDougall will put it on the website.
