Russ Elmhirst asked if markers for the cemetery were ready yet. Koviak said he checked on this today and they are not ready.

Dave Patterson asked if comments may be made during the meeting. Koviak said yes.

MOTION: Moved by Pillen, supported by Hodulik to approve the minutes of the May 5, 2016 board meeting as presented and payment of the bills. **MOTION APPROVED**

New Business

Township Newsletter – Pillen

Pillen distributed copies of the newsletter to be inserted in the summer tax bills. Koviak will make copies and deliver them to Reimann.

Annual Spring Clean Up Day – Koviak

Annual Clean Up Day is June 18, 2016 at the East Side Transfer Station on Crump Rd., from 9 am to 4 pm. Flyers are being distributed at both transfer stations.

Sponsors are BLPA and Michigan DEQ Scrap Tire Clean Up program. Koviak will try to get help to assist residents in unloading. Dave Patterson said he will get volunteers from BLPA to help.

Burt Lake Trail – Hodulik

The issue for paying for trail maintenance has been discussed at recent Trail meetings.

MOTION: Moved by Pillen to establish a yearly Trail Maintenance Account in the general fund budget in the amount of \$5,000.00 beginning with the 2017-2018 budget.

Discussion: Hodulik said it should begin with this year's budget. Pillen said he agreed and said he would like to amend his motion.

Hodulik said he and Pillen attended a trail meeting in Cheboygan last year and Benton Township has already set up a trail maintenance account.

Hodulik said Emily Meyerson said Emmet County paid \$9,800 for 14 miles of maintenance on their paved trail (work performed by Road Commission). The cost for maintaining a crushed stone trail is \$765/mile.

Patterson said he talked with the director of grants for the DNR and was told they do not have grants for maintaining trails.

Pillen withdrew his Motion.

MOTION: Moved by Hodulik, supported by Pillen, to create at capital improvement fund for trail maintenance from the general fund beginning with the 2016-2017 budget in the amount of \$10,000 per year and also using any leftover funds from the budgeted Parks and Recreation line item for this fund.

Koviak said he talked to Brent Shank from the Road Commission. They will not be able to crack seal Cedar Drive, Cedar Point Dr., or Deerfield Lane as the roads are in too bad of shape. They will duropatch them instead at the expense of the County and the township will save \$2,240.

Nora Stanbury asked what is the purpose of the Cheboygan County Humane Society. Chris Brown said it is for animal control. She asked who pays for it. Koviak said each government entity contracts with the Human Society. She said Cheboygan County Humane Society kills more animals than any other Humane Society and she does not like that. Chris Brown said he will check on it.
