Public Comment:

Bob English, Mullett Township Fire Dept., gave a brief report on the deadly fire on the east side of Burt Lake. He said counseling was available for the fire and rescue personnel.

Mr. English noted that the department has received several calls regarding dust on Service Road which looks like smoke from the Expressway. Koviak said dust control will be applied after the Road Commission is done working on it.

Mr. English said that a nice job was done on Numbers Road.

Cheboygan County is still under a burn ban on order of the DNR. Small pit fires are allowed.

Municipal Underwriters of Michigan, Inc.

Adam Gandolfi attended the meeting to go over changes to the Burt Township liability insurance. Grants are available for projects that would reduce risks of injuries.

Old Business

<u>FEMA Flood Plain Insurance</u> – Hodulik

An informational meeting will be held on July 25, 2012 at 7:00 pm at the Burt Township Hall, on the FEMA Flood Plain Insurance Program. Sue Conradson, FEMA Representative, and Al Hoard, Cheboygan County Building Dept., will attend to answer questions. Information will be placed on the Burt Township website and in local newspapers.

<u>Spring Clean Up Day</u> - June 16, 2012, 9 AM to 4 PM – East Side Transfer Station – Koviak BLPA donated \$1000 for the annual Spring Clean Up day. They will also provide volunteers. Koviak will also hire a couple of individuals to help on that day.

Roads – Hodulik

Hodulik prepared an Excel spreadsheet of all roads in the township including the length and condition of each road. This list will be used as a guide for future road millage and maintenance projects.

New Business

2-1-1 - Koviak

Cheboygan County United Way Executive Director, Burnice Myers representing the 2-1-1 service was at the Cheboygan County Chapter MTA meeting in May. They are in need of funding to match a grant for Cheboygan County. 2-1-1 is a non-profit organization that connects individuals with health and human service agencies. 2-1-1 is an especially useful tool in emergency and disaster situations. Anyone with a cell phone can be put in touch with area resources. Attorney Tim MacArthur prepared a legal document allowing Burt Township to give a grant to 2-1-1 for Health and Human Services in Cheboygan County.

Note: Clerk called United Way on June 12, 2012. They now have necessary funding for the 2012 start-up through a donation from Caresource Insurance. No check was issued to 2-1-1.

MTA – Pillen and Hodulik

Pillen and Hodulik attended the MTA Spring Regional Meeting on May 15th in Gaylord. Pillen reported on the session on Establishing Better Relations with your Road Commission. He said that Road Commissions generally are not maintaining roads with less than a 4 rating (attached report). Hodulik reported on the Planning for Wind session on wind turbines and noted that Michigan has large windmill farms in the Ludington and Thumb areas.

Foreclosed Properties – Koviak and Reimann

Eight parcels in Burt Township are in foreclosure and up for tax sales. Six are owned by Koyl off Indian Road/Hardwood Road and do not have addresses. The remaining two parcels are at 6526 W. Numbers Road and is owned by Sagante, and Happy Heights Sub Lot 97 on Peace Trail (owner unknown). A public auction will be held in August.

MOTION: Moved by Hodulik, supported by Koviak not to bid on any of the tax foreclosed properties listed in Burt Township in 2012.

Burt-Mullett Cemetery Board - Koviak

The Burt-Mullett Cemetery Board has been meeting with Tim MacArthur to develop an intertownship agreement for the cemetery. A Quit Claim deed was prepared to make the old section of the cemetery joint with Mullett Township. Rules and an Ordinance have also been written. Mullett Township passed the same Agreement on June 5, 2012. The Ordinance will take effect 30 days after publication.

MOTION: Moved by Pillen, supported by Hodulik to enter into an Intertownship Agreement for Operation of a Joint Cemetery Board and acceptance of the Cemetery Rules.

Resolution in Opposition of MNRTF dollars being diverted to fund State Projects – Koviak The Northeast Michigan Council of Governments is requesting local officials to approve a resolution to oppose the Michigan Natural Resources Trust Fund dollars being diverted to fund State projects (general fund). They would then like the copies of the resolution to be sent to State officials in Lansing.
