John Wojciehowski commented on the status of the challenge to reduce fire insurance costs for township residents. Wojciehowski said that even though Randy Bricker said there is no grant money to erect a substation on the U of M property, he does not want to give up on that avenue and has written a note to both U of M and the Pellston Fire Department to that effect. He also wants the board to encourage the Pellston Fire Dept to become ISO (International Standardization Organization) certified which will also lower insurance rates considerably.

Steve Vorenkamp said there are two issues, safety and saving homes and also insurance savings. He asked if this should go through the Planning Commission or the township Board. Pillen said he will look into this.
