- Hold harmless: BEA will need to be certified to the Township by the State this would give blanket protection except if an existing contaminated area is disturbed by the Township – no ETA provided

3. <u>Indian River Library</u>

- Kathy Cole (President of Indian River Library Board) and Kelsey Rutkowski (Director) are asking for 50% of Burt Townships penal fines in exchange for township residents to use the library for free
- Library has been renovated and resources/services include e-resources (audio books, e-books, etc.), MEL (library sharing), new technology, maker space, meeting room available for reservation, free wi-fi, four computers for use, homebound patron service (deliver books to those who cannot get to the library)
- Eleven Burt Township residents currently use the Indian River Library
- Reciprocal borrowing allows you to go to other area libraries with the exception of Cheboygan Kelsey to provide updated reciprocal borrowing list to the board
- Library hours: T/TH 10-7pm, W/F 10-5:30pm, Sat 10-2pm, starting in January they will be open Mondays 10-5:30pm
- Contract would be for three years for 50% of the annual Penal fines
- Burt Township currently has a contract for 50% of the penal fines distributed to the Topinabee Library since mid-1980s and the board will review the reciprocal borrowing list when provided

4. <u>Planning (Zoning Amendments)</u>

- Planning provided additional definitions and changes to accessory building sizes based on acreage and zoning district
- Larson identified 2 grammatical errors and a suggestion to change the Rural Residential minimum lot width from 200 to 235 feet

- Phase three has not been officially closed out by Huron Engr and MDOT
- Hodulik received 2 invoices from Dana Stempky (MDOT) for approximately \$292,000 that has been paid by MDOT to J &N Construction, The bid was for \$507,700
- Invoice received form Huron Engineering was higher than the balance of the contract, Huron engineering to review the invoice
- Signs ordered for the trail, to be installed in May
- Going to meet with Maple River Township about the trail going west to Brutus

• Started talking about the survey that needs to go out to property owners in February

- 2 permits pending through the end of the year

• Tim McArther commented that library penal fines are currently at \$16,551.53 (being held in escrow) for Burt Township. That amount accumulated since 2014 when the Indian River contract expired. If the township signs a new contract with Indian River they would get that escrow amount allocated to them.
