UNFINISHED BUSINESS

1. Blight Ordinance

• At MTA meeting in March, Sheriff Claremont, Deputy Ginop and Amber Libby (Assistant Cheboygan Co. Prosecutor) were in attendance and they went through the ordinance with the townships that are signed up (Burt Township is not signed up). Sheriff Claremont stated several times that the ordinance is responsibility of the township and not their office, they will only enforce

NEW BUSINESS

2. Fire Road Millage

- Survey results 51% response rate (348 surveys, 177 responses)
 - i. Vote for ½ mill for fire? West side = 65% yes, East side =59% yes
 - ii. Vote for ½ mill for roads? West side = 44% yes, East side = 41% yes
- Suggestion is to only add the ½ mill for fire to the August ballot based on responses
- Cheboygan County will be adding a road millage to the November ballot
- MacArthur has provided the millage language and the Resolution to add the millage as presented to the August primary election. Fred Lindroth to provide the estimated taxable amount

MOTION: Moved by Hodulik, supported by Parker to authorized placement of a fire millage proposition on the ballot for the primary election to be held August 2nd 2022. Resolution is for ½ mill for 2 years

3. Anavon Proposal

- Proposal to have cameras installed and signage provided for the town hall ballot box
- Mark Garrett from Anavon said the senate bill was passed and needed to be in effect by June 1 but Koviak spoke to Judy Allen (lobbyist for MTA) and she said the bill has not been approved by the house or signed off on. Per Allen, even if it is passed in the next couple months it won't go into effect until 2023
- Koviak suggested to postpone the decision and get a second bid (Sunrise Electronics in Petoskey)

4. BSA Software Proposal/Cougar Mountain Software Proposal

- Background from Kozlowski: Currently on QuickBooks for payroll and accounts payable and per QuickBooks (QB) our file has been corrupt for several years and is the reason why we are having issues with it. QB is not a product that caters to municipalities, customer service is very bad, and they are asking for additional fees to fix the files. Per Kozlowski's research, two companies providing municipality focused software have received excellent reviews from other clerks and bids from both companies have been obtained:
 - BS&A (currently used for assessing and taxes) \$36,390 initial setup with \$7,110 annual service fees after first year, turnaround time is 9 months
 - Cougar Mountain Software \$10,626 initial set up, \$1,049 annual service fees and 4 hours of support (if needed) at \$540 after the first year, set up could be complete by June 1
- Discussion among board members: Cougar Mountain Software is highly recommended, turnaround time is much quicker, and the fees are much less than BS&A. BS&A is also highly recommend but caters more to larger municipalities and the cost is much higher as well. Since QB contract is up for renewal in May, it makes sense to make the decision now

MOTION: Moved by Hodulik, supported by Kozlowski to approve the Cougar Mountain Software Proposal for \$10,626 to replace the current QB software
