Fire Agreement with Mullett Township - Koviak

Trail Parking - Hodulik

MacArthur agreed to being notified if a contractor parks on the trail, and he will write a letter requesting them not to park on the trail.

Annual Spring Clean Up Day - Koviak

Big Dump Day was a great success on the East Side.

165 residents brought loads and another 100 brought household trash.

This resulted in 5.5 compacted loads, 88 regular tires and 7 large tires.

Cost was \$4186.00.

BLPA is donating \$1200.00 for the clean-up day.

### **Burt Lake Trail** – Hodulik

Phase II is complete, and a walk-through inspection was held on June 17. Two benches are needed and the entrance to the gorge needs vegetation to be planted.

Phase III - Huron Engineering completed the quarterly report to MDOT. They are working on the survey for UofM. Also needed is the Shippo letter. The archaeological study is complete and the paperwork has been submitted.
