MOTION: Moved by Hodulik, supported by Parker to approve the Agenda with deletion of planning amendments (public hearing needed first) and additions of Merit Renewal and internet discussion

PUBLIC COMMENT – Fred Lindroth asked that the Poverty Exemption Income Guidelines and Asset Test Resolution be re-signed due to deletion of a sentence.

UNFINISHED BUSINESS

Fire Agreement with Mullett Township – Koviak

Hodulik comments on rough draft from Tim McArthur:

- Sent copy of rough draft to Mike Goerke and Brett Lindgren from Mullet Township
- Part 1 of draft contract need to add the Burt Township sections to be included in the agreement: 1-3, 10-14, 23-26, 35-36, plus the north end, including the 4-5 houses on the west side of Roberts Rd
- Re payments Revise second payment verbiage of "no later than March 31" to "six months after the first payment" which would be in November
- Current draft contract is for 5 years versus the 10 years previously discussed
 - O Per McArthur, existing millage runs 2020 2023 and the township should consider a 3-year contract or a 5-year contract with the intent to pay the extra ½ mill even if it doesn't pass
- Need language added: First quarter of calendar year, when we need to renew 1 mill on the ballot, townships would review the cost and determine if there needs to be an increase or decrease in the mill

- Need language to address the possibility of the 1 mill not getting approved by the taxpayers should result in termination of the contract
- Intent is to put the ½ increase to the mill on the August 2022 ballot and in the interim, the Township will issue a survey to the residents about what they will be paying and the importance of it

Randolf Bricker asked if Pellston will get the same as Mullet. Per Koviak, they will get the 1 mill if it passes but won't get any more until that happens. If Pellston would like to bring a proposal to the Township for the next two years it will be reviewed and voted on by the Board.

Corner Property at Crump/Burt-Mullett Road

- Tim McArthur received a letter from EGLE and addresses previous concerns
- EGLE is requesting that Burt Township write a letter to confirm our intent to continue with the property purchase/transfer and for EGLE to proceed with the Baseline Environmental Assessment Kozlowski to draft and send the confirmation letter to EGLE and copy Renee Kinney
- Kinney asked if the Board has decided on swap price
 - o Kinney property, per assessment, is estimated at \$12,000, with no environmental contamination
 - o The Board will have the Burt property assessment by the next meeting and a decision can be made on price

Franchise with PIE & G for fiber

- Slowinski, who mowed Phase I, will also mow Phase II of the trail
- Still have a problem at the gorge. Brent Shank looked at it and said there is nothing they can do. Hodulik to meet with Spierling to see what else can be done possibly dig out sand and replace with crushed rock
