## Burt Lake Trail Report – Hodulik

The DNR Trust Fund grant was updated to get more points. The MDOT application data was entered and Hodulik was informed that MDOT will give conditional commitment for Phases 3 and 4 when construction on Phase 2 begins.

The Trail Committee is ordering 7 ½" signs for the trail and work vests for the volunteers.

#### <u>ZBA</u> – Koviak

The ZBA met on September 21, 2018. Two variance requests were given:

1) Michael and Catherine Flynn, variance for 7018 Needles Road, Indian River, Michigan 49749 (parcel 120-026-400-032-00) to build an addition within the 10' side setback and also increases the maximum allowed coverage by structures.

2) Katrina Schock, variance for 10478 Brutus Road (parcel 120-020-400-004-00) regarding Article 6.04.1b of Article VI – Accessory Buildings with Principal Use exceeding the maximum 1800 sq ft allowed to have a 2400 sq ft (36'x64') footprint.

The next meeting is November 30<sup>th</sup> at 2:00 pm. The only topic so far is Mr. Chris VanWormer's tabled request for a pole barn on Indian Road.
