## Solar Farm Ordinance - Jontz

Cheboygan County passed its Solar Farm Ordinance, however, it is very detailed and not applicable to Burt Township's needs. It will be reviewed and revised at the May meeting.

### Parking on Trail - Jontz

It was decided that the best way to start the process of reducing parking on the Burt Lake Trail would be to put up "No Parking" signs. If that does not work, then a police power ordinance will be considered.

#### Transfer Station Access - Jontz

Koviak said additional hours for the transfer station will not be considered at this time but having a shred service sometime this summer will take place.

*Jontz* suggested a good communication tool would be to put up a sign board to post notices. This will be looked at this spring.
