Zoning Board of Appeals Report Representative – Jontz

2 of the 4 variance requests were approved; one was tabled, and the other one needs permits.

ZONING ADMINISTRATOR – Jim Larson

Possible 4 variances at next meeting February 26, 2021, at 2:00 p.m.

Larson had 3 issues: definition of fire pits, how to measure a lot for the high water mark, and what to do about contractors working without permits.

OLD BUSINESS

HIGH SPEED INTERNET – Kozlowski

We had a Zoom presentation by Michael Reen from Aspen Wireless. Aspen Wireless is willing to build a buried high-speed fiber network for Burt Township at its expense. It is estimated to cost approximately \$4 million. Assuming 400 homes would commit, it would cost each home owner \$10,000 over 10 years or approximately \$117 per month for that time period of which \$83 per month is for the internet structure and the remaining \$35 per month is for the service itself. Aspen will provide the financial data presentation for Allen to send to the members of the planning commission. He discussed another approach where another company puts in an underground conduit and an ISP partner (like Charter or Comcast) installs the fiber optics. The next task is to identify at least 400 homes to contact as possible customers. Three RFP responses for feasibility studies were Cherry Capital Communications (Elk Rapids) for \$195,000 (6 – 8 months to complete), Yates Engineering (Indiana) - \$22,898 (8 weeks to complete), and GEO Partners LLC for \$3600, done off site. This will probably require an association of members to be created after the initial 10 years.

ACCESSORY BUILDING AS A PRINCIPAL USE/LOT SIZE AMENDMENT

This is tabled until next meeting to define sizes when accessory building is not the principal use (home already exists).
