## Archeological Study

Gary Walz sent in a proposal to complete the archeological study at a cost of \$3,452.00. Dave Boyle said OHM could hire the archeologist and then bill the township. Parker will contact Bill Rutter who completed the study for Phase I to bid the job, too.

### Phase III and IV

The strategy is to combine the Phase III and IV project with the DNR and TAP Fund grants. At the MTA meeting, Brent Shank mentioned that this is an important project, as it will be a joint project between the Township and the Road Commission.

A Public Hearing will be held on March  $12^{th}$  at 6:30 pm to take comments on the project for the grant and the application will be submitted by March  $31^{st}$ .

A contract is needed from OHM for Phase III and IV. Dave Boyle already has much of the data needed so it is expected that the price will be somewhat less.
