**APPROVAL OF MINUTES:** Motion by Kozlowski, supported by Landon to approve the March 14, 2024, minutes. Motion approved.

## **OLD BUSINESS:**

**High Speed Internet:** Kozlowski said there are no reported updates from Spectrum. Construction within Burt Township will be financed by the Robin Grant.

Master Plan Review (Chapters 5 & 6): Topic by topic was reviewed for Chapter 5, "Community Services, Facilities, and Transportation," with updates required under the headings "Other Public Utilities," "Recreation – Burt Lake Trail," "Other Protected Lands."

Review of Chapter 6, "Community Goals and Objectives," resulted in a change of township millages to one mill for fire and roads, and an update of parks and recreation actions.

**Tip of the Mitt Watershed Council Presentation:** Marcella Domka presented methods of shoreline restoration to prevent erosion and maintain high water quality. Ann McGlashen presented approaches for improving septic systems using inspections by the health department particularly at time of a home sale and possibly homes used as short term rentals. In summary, McGlashen suggested that we meet with the District 4 Health Department representative, join the Burt Lake Watershed Advisory Committee and attend their next Zoom meeting on May29, 2024, at 10 a.m. Contact <a href="mailto:lauren@watershedcouncil.org">lauren@watershedcouncil.org</a> for more information.

**Zoning Ordinance Amendment**: Changes of plot plan, site plan, and campground requirements were approved at the public hearing prior to the regular Planning Commission meeting.

**Discussion—Zoning Ordinance—recreational vehicles, trailers and tents:** preliminary discussions led by Ken Lane resulted in the decision to table further talks until the next meeting July 11, 2024.
